7. New Business

7.1 Policies

AS Paper No. 25-48 – Policy on Awarding Credit (New)

This policy was presented to the Academic Senate for its urgent consideration as it is required to complete the accreditation application to SACSCOC. The Chair reminded senators that the process for approving a policy "usually" required that a policy be presented to the Academic Senate twice. However, given the pressing need for this policy, she should be willing to have an extraordinary meeting if senators were unwilling to vote on the policy at this meeting. After a discussion, it was agreed that a vote on the policy should be taken.

7.5 Reports of Academic Senate Committees

7.5.1 Statutes, Bye-Laws and Rules – T. Micklewhite – Chair No update was available at this time.

7.5.2 Committee on Committees – D. Hepburn – Chair

7.5.3 Faculty Development – R. Gardiner – Chair

R. Gardiner reported that the Committee met and reviewed some of their concerns. The Committee met with one of the executives of UTEB and will schedule a meeting with the Provost and VP, Academic Affairs. There are some outstanding issues that must be dealt with one of them being the survey that should have been completed in one of the previous faculty development committees however, they are not sure that the survey was administered and they will do further investigation.

7.5.4 Curriculum/Academic Programmes – P. Jones – Chair

P. Jones reported that In February 2025 the committee met and passed three programmes, they also met in March 2025 where five programmes were worked on and passed in today's Senate meeting. The next meeting is scheduled for April 2025 where additional programmes and courses will be considered. The work of the committee will continue through May and June.



7.5.5 Academic Policies Committee – C. Archer – Chair

C. Archer reported that the committee approved three of the four online learning policies, Online Learning, Accessibility in Online Learning and Privacy in Online Learning. They have been trying to look at the Gen Ed policy which is a large, data intensive document and requires additional time for review.

She noted that the fourth policy, the Learning Management System Policy which is connected to online learning also has a component dealing with intellectual property. She noted that they will have to address the intellectual property component before they can address that policy. She also noted that the committee received some information from Secretary W. Fielding that was helpful as they develop a draft.

7.5.6 Student Affairs Committee – L. Lopez – Chair

L. Lopez reported that the committee met on 1 April 2025 which concluded a total of five meetings for the Academic year. At that meeting, Ms. Tilus, on behalf of VP, Student Affairs shared concerns for the Senate to assist with.

They included consideration for:

- a centralised model for academically advisement of students where there are trained student affairs professionals staff advisors to work along with faculty
- Counselling 100 to be taken in the first semester or in the summer II semester.
- Academic Calendar needs an inclusive approach
- Acceptance letters are provided too late
- Accommodating students with disabilities in the classroom
- The enforcement of the dress code policy

The committee agreed to conduct a courtesy call with the VP. Academic Affairs in the new academic year. L. Lopez gave an overview of the upcoming commencement ceremony which will be held on 27 May 2025. There are approximately 650 students who will be graduating.

7.5.7 Research and Creative Works Committee – A. Kabir – Chair

A. Kabir reported that the Committee had had a meeting last week and agreed on some recommendations to promote and support research:

- 1) That the Graduate Office arranges a Research Edge session in the fall semester for the students who complete top quality course projects the spring semester.
- 2) That there is a need to develop channels for better communication about understanding the IRB policies and thus recommends a slot be given in the faculty seminar for presentation on the IRB.
- 3) That there is low attendance at the Research Edge Forum and out forward the idea of changing the time from 2 pm to 12 pm on Friday with occasional incentives for example coffee and cookies.



The Committee will send all the minutes of meetings this semester to the Secretary of the Academic Senate.

7.5.8 Faculty Handbook – N. Bandelier – Chair

N. Bandelier reported that the Committee is not fully populated, but it is functioning. It met on 1 April, 2025 and it is currently awaiting the signed official copy of the Industrial Agreement, however it has a document that it is working from.

The Committee had discussed changes that need to be made to the faculty handbook and it is its recommendation that general faculty body read the handbook to dispel some of the misunderstandings that have been taking place. The Committee hopes to have the document completed by the end of June 2025.
