#### **MINUTES**

- 1. Call to Order The meeting was called to order at 2:17 p.m. by N. Bethel.
- 2. Roll Call This was taken by W. Fielding.

### 5. Approval of Minutes

#### 6. Remarks

6.1 **M. Woodside-Oriakhi, Provost & VP, Academic Affairs** – She highlighted two significant milestones to celebrate this year: the first being the 50<sup>th</sup> anniversary of this institution and the second, the submission of the application for international accreditation this fall semester.

She thanked senators for approving papers necessary to support the accreditation application. In addition, many senators had been involved with assessment reports and also with the faculty credentialing process.

She thanked the Academic Senate for all its support during the last academic year and she looked forward to working with the Academic Senate in advancing the mission and vision of the institution.



6.2 N. **Bethel, Chair** – The Chair thanked the Senators and the officers for their support as she starts her role as Chair.

The Academic Senate is a governance body. She invited senators to use these Tuesday meetings and their committee meetings as opportunities to engage more with the role of governance and the role of the Academic Senate.

Senators have an opportunity to affect the next 50 years of the University. What might that mean and look like as the Academic Senate propels the University forward? What might it entail? How might it look? The focus of the University is academics and its academic authority is an Academic Senate not a Faculty Senate. There is a need to determine the boundaries of the Academic Senate and the Office of Academic Affairs, governance and administration are different, but related. Further, the Academic Senate needs to determine how it works alongside the University's other governing body, The Board of Trustees.

Senate meetings, in particular the meetings of the committees of the Academic Senate, must be the highest priority of all meetings which senators attend. The Chair expressed her hope that when items come to the Academic Senate that they will address principles such as, how do they affect academic freedom? How do they contribute towards the University's mission? The work of the Academic Senate must be evidence based, focused on principles and indicate that it has done due diligence.

The Chair was of the opinion that the University's graduation ceremony is due for review. It was concerning that students did not stay until the end of the ceremony. How might the Academic Senate affect the change that will make graduation from University of The Bahamas a sacred and joyous occasion?

There was a brief discussion about graduation and the Chair stated that Senate will seek to prepare a resolution on this matter through suggestions and recommendations.

# 7. New Business

### 7.1 Terms of Reference of the Faculty Handbook Committee

The Chair noted that the Faculty Handbook Committee is the newest standing committee of the Academic Senate. She shared the proposed TORs. The Committee will meet four times in the Academic year to ensure that the text in the handbook is up-to-date each June.

The proposal stated that the Committee will be composed of three senators, two faculty, one staff, and one person nominated by the Provost and Vice President of Academic Affairs.

Many questions and suggestions were raised from the floor.

A motion was made by D. Barkey and seconded by N. Wallace-Bandelier to increase the Faculty Handbook Committee members by one additional non-senate faculty member. The motion was approved.

On a motion by N. Wallace-Bandelier and seconded by M. Sairsingh the faculty handbook working TORs were approved with amendments.



# 7.2 Population of Academic Senate Committees

At the end of the last session, approval was given to reduce the number of meetings for committees so that senators would not be over-committed and would be able to conduct the work of the Academic Senate. N. Bethel noted that all of the committees are quorate and so can start working. A working schedule of the meeting dates of the Committee was shared so as to overcome the issues of quorum which had been experienced in previous years.

The Secretary noted that Senate Committees should meet on a Tuesday between the hours of 2:00 pm - 4:00 pm and the business of the first meeting should be to select a chair and a secretary.

#### **Terms of Reference for Faculty Handbook**

The Faculty Handbook Committee will ensure that the text of the Faculty Handbook is up-to-date by June of each year so that the Office of Academic Affairs can share the Faculty Handbook with all Faculty at the start of the Academic Year.

The Committee will be composed of:

Three senators (two faculty, and one staff), one faculty non-senator and one person nominated by the Provost and Vice President of Academic Affairs.

The Faculty Handbook Committee will meet no fewer times than four times per Academic Year
