One option is within the powers of Senate; the relevant clause in the Statutes and Bye-Laws needs to be changed from election/appointment "held every two years" to "held every year." The other option is to change the overall governing statues of the University in the Act in the second Schedule and ask the Board of Trustees to change the term to three years.

7.4 Proposal for implementing a three-tier degree classification system – Information

The Chair shared this proposal with the Senators and asked them to read it so that there can be further discussion.

7.5 Vacancy on the Academic Senate for a Staff Representative – Information

Report Overview

At the beginning of the semester, we divided our work into three categories: tenure, post-tenure, and promotion. By mid-semester, we agreed to focus primarily on developing the criteria for tenure, with the intention of addressing post-tenure and promotion in the next academic year.

We conducted research on tenure criteria at various institutions and selected four universities for focused review: Tulane University (New Orleans), Boston University, New York University, and Miami University.

Assignments

The following assignments were made:

- The task of reviewing the criteria for tenure at Tulane University was assigned to Professor Jessica Minis.
- The task of reviewing the criteria for tenure at Boston University was assigned to Professor Marlo Murphy-Braynen:
- The task of reviewing the criteria for tenure at New York University was assigned to Professor Christina Moseley
- The task of reviewing the criteria for tenure at Miami University was assigned to Professor Shelby McPhee.

To increase coverage and cross-analysi, Professor Kayla Stubbs was in charge of looking at the criteria for tenure at Tulane University and Boston University, myself (Marky Jean-Pierre) did so for New York University, and Miami University and Professor Dion Hepburn had the option to pick up any two of the set of 4 universities.

We express our sincere thanks to all colleagues for their contributions and collaboration.

Debriefing Meeting – May 5, 2025

During our final meeting of the semester, we conducted a debriefing to evaluate our progress and set priorities for the next semester.

The discussion focused on:

- 1. A review of tenure criteria at the four selected universities.
- 2. Key concerns, challenges, and questions related to tenure criteria at UB.
- 3. Action items for the first part of the 2025–2026 academic year.

Summary of Tenure Criteria Review

We found that tenure criteria generally revolve around institutional mission alignment, teaching, research/scholarship, and service, with some institutions allowing flexible combinations of these elements. We found that these patterns closely align with UB's current faculty promotion practices.

Concerns, Challenges, and Points for Reflection

- Ongoing concerns about tenure policy distinctions, particularly the one-year permanent status for Bahamian faculty versus a formal tenure-track system.
- Disparities in treatment between Bahamian and non-Bahamian faculty.
- Alignment of tenure criteria with SACS accreditation standards for faculty qualifications.
- Coherence between proposed tenure criteria and existing UB policies.
- The challenge of adapting tenure criteria to the local academic environment while ensuring international competitiveness.
- Consideration of a 3-year tenure-track (as opposed to the 5-year model typical in the U.S.).
- Designing a tenure-track that prioritizes promising Bahamian scholars (with at least a Master's degree), supporting them toward PhD completion, while also facilitating residency pathways for foreign faculty.

• The difficulty of promoting local faculty without PhDs in reference to the need to balance local hiring with academic standards.

Tasks for the Next Semester (AY 2025–2026, Part 1)

- Review Standard 6 of the accreditation application and examine relevant definitions before making final proposals to the Senate.
- Schedule a meeting with Dr. Tucker, the VP of Academic Affairs Dr. Oriaki, and the VP of Human Resources early in the semester to gather feedback.
- Use insights from these meetings, the tenure criteria reviews, and internal committee reflections to draft a tenure criteria proposal for the Academic Senate.
