1. Authority

Title:

Board of Trustees

2. Purpose

The purpose of this policy is to establish a procedure for the selection of a commencement speaker.

3. Scope

This policy applies to all members of the University Community involved in the nomination or selection of Candidates for commencement speaker.

4. Definitions

Committee: For purposes of this policy is the Ceremonial and Occasions Committee chosen to serve as a liaison between the general campus community and the University Secretary during the commencement speaker nomination and selection process.

5. Policy Statement

5.1. Selection Criteria

5.1.1.All nominees should in some way epitomize the goals and mission of the University of The Bahamas and should exemplify "Knowledge, Truth and Integrity".

- 5.1.2. Candidates must meet one or more of the following criteria:
 - Have a distinguished record of teaching, scholarship, or service their community
 - Have record of significant achievement in her or his field
 - Have exhibited exemplary leadership in public service or business
- 5.1.3.University of The Bahamas is an inclusive, diverse and equal opportunity space, therefore we shall attempt to alternate the sex of the speaker each year.
- 5.1.4. Sitting politicians are not to be selected as commencement speakers. Exceptions only considered by the President.

5.2. **Nomination**

- 5.2.1.University Trustees, faculty, students, staff, alumni, and other members of the University Community may recommend a potential Candidate to the Ceremonial and Occasions Committee using the form provided.
- 5.2.2.If an Honourary Doctorate is being presented at the Oakes Field Campus, a speaker is to be selected for UB North Campus only. If an Honourary Doctorate is being presented at the UB North Campus, a speaker is to be selected for the Oakes Field Campus only.

5.3. Compensation/Costs

- 5.3.1. The University does not pay honouraria to Commencement Speakers.
- 5.3.2. The university will cover the cost of travel and accommodation for speakers who live out of country or off island.
- 5.3.3. The University will also cover the cost of ground transportation during the stay.

6. Procedure

- 6.1. Nominations for Spring Commencement Speaker are called in January. They are sent out by the Bord Secretary via the Office of University Relations to the university community and constituents.
- 6.2. Nominations are received by the Chair(s) of the Ceremonial and Occasions Committee.
- 6.3. The Committee reviews the submissions against the criteria for selection and nominees are ranked based on the selection criteria.
- 6.4. The Committee submits its top five (5) candidates in order of preference to the President and includes its justification of the selection.
- 6.5. The President submits the list of 5 or a shorter list of preferences to the Board for final approval.
- 6.6. Once the Board has decided on the preferred candidate(s), one for Oakes Field and one at UB North, the selected candidate(s) will be notified of their nomination.
- 6.7. Depending on the candidates' acceptance or refusal, another nominee may be contacted to be keynote speaker at the commencement ceremony.



SPRING COMMENCEMENT SPEAKER NOMINATION FORM

Members of the UB community are encouraged to nominate individuals to be considered to give the commencement address. To be given serious consideration, the individual being nominated should have distinguished him/herself by making important contributions to society through scholarship/academics, business, public service, social, political, scientific, artistic or charitable works. The nominee should have the demonstrated ability to share his/her thoughts and ideas in public forums in ways that inspire new questioning of old ideas and promote responsible social action. Documents in support of the nomination, for example, curricula vitae, articles by or about the nominee, letters of support, or more complete biographical information should be attached to this form. A separate form must be submitted for each nominee.
