SUMMARY: The Plumber II is responsible for installing, preparing and maintaining pipes, fixtures and other plumbing used for water distribution and waste water disposal in residential and commercial buildings while working in a safe manner and keeping work area clean.	
SPECIFIC DUTIES/RESPONSIBILITIES The duties of the Plumber II include but are not limited to the following: <ul style="list-style-type: none"> • Install, repair and maintain plumbing systems and components. • Review building plans and specifications to determine the layout of plumbing and materials. • Identify required tools and special equipment. • Select the type of size of pipe required. • Locate and mark positions for connections and fixtures. • Install supports and hangers for pipe, fixtures and equipment. • Assemble and install valves and fittings. • Install, repair and maintain all portable and non-portable water systems. • Install, repair and maintain water heaters. • Install, repair and maintain all plumbing fixtures, appliances and trim. • Test pipe systems and fixtures for leaks. • Ensure all installations, repairs and maintenance meet code requirements. • Must be able to solder weld. • Must be willing to cross trade. • May be called out at odd hours or have to work long hours in cases of emergency. • Mentors fellow employees to enhance their skills.

PHYSICAL/ENVIRONMENTAL/WORK REQUIREMENTS

- Stand or walk for long periods of time during the regular work day; use arms and hands to reach for, handle and manipulate objects.
- Lift and carry materials weighing 50lbs to 100lbs, climb up and down ladders, work at heights and other climbing devices while carrying tools and other equipment.
- Worked while in stooped, kneeling, crouched and crawling positions.
- Perform assigned tasks under all types of environmental conditions. May include areas where toxic or caustic chemicals or fumes are in use or being stored.
- Will be required to operate power tools.
